THE CORPORATION OF THE TOWN OF MISSISSIPPI MILLS

BY-LAW NO. 01 - 40

BEING a by-law to regulate Outdoor Solid Fuel Combustion Appliances

WHEREAS the Council of the Town of Mississippi Mills wishes to promote wood source heating as a sustainable, renewable source of energy;

AND WHEREAS the Council of the Town of Mississippi Mills considers Outdoor Solid Fuel Combustion Appliances to be a wood source heating system which may have the potential as a public nuisances;

WHEREAS Section 210 paragraph 140 of the Municipal Act, Chapter M.45 R.S.O. 1990 as amended, authorizes councils to pass by-laws prohibiting and abating public nuisances;

NOW THEREFORE the Council of the Corporation of the Town of Mississippi Mills enacts as follows:

1. Definitions:

- (a) "Outdoor solid fuel combustion appliance" means a solid fuel burning appliance, which is used for the space heating of buildings, the heating of water or other such purpose; and which is located in a separate building or on the exterior of the building which it serves.
- (b) "Waste" shall mean any material defined as waste in Section 25 of the Ontario *Environmental Protection Act*, Chapter E.19, R.S.O. 1990, as amended.
- 2. This by-law applies to all lands within the geographic limits of the Town of Mississippi Mills.
- 3. Outdoor solid fuel combustion appliances shall be permitted on properties zoned "RU" or "A".
- 4. Outdoor solid fuel combustion appliances shall be located on a permitted lot such that they are a minimum of 50 metres (165 feet) from a dwelling on an abutting property, or 145 feet from the side lot line when abutting a vacant lot. In no case shall an outdoor solid fuel combustion appliance be located closer to a lot line than the minimum setback requirement for the principle dwelling as expressed in the relevant zoning by-law.
- 5. Notwithstanding the provisions of Section 3, outdoor solid fuel combustion appliances are not permitted on any lot, which is located within a registered plan of subdivision or within a Hamlet or within the limits of the Almonte urban area as identified in the Town of Mississippi Mills Official Plan.

- 6. Where such installations are otherwise permitted in this by-law, there shall not be more than one (1) permitted per property in the Town except:
 - (a) More than one (1) outdoor solid fuel combustion appliance is permitted on a lot where it serves a permitted accessory dwelling or an agricultural building on lands which are used primarily for agricultural purposes.
- 7. The installation of outdoor solid fuel combustion appliances shall be in compliance with the Ontario Building Code, the Ontario Fire Code, the manufacturer's installation instruction and all other applicable law.
- 8. No outdoor solid fuel combustion appliance shall be used for the incineration of waste.
- 9. Any outdoor solid fuel combustion appliance is existence on the date of passing of this by-law, which was legally installed under authority of a valid building permit, shall be deemed to be in compliance with the provisions of this by-law.
- Any person or persons who install, use or maintain an outdoor solid fuel 10. combustion appliance in contravention of the provisions of this by-law are, upon conviction, guilty of an offense and subject to a fine pursuant to the Provincial Offences Act., Chapter P. 33, R.S.O. 1990 as amended.
- 11. Prior to the installation of any outdoor solid fuel combustion appliance a permit shall be obtained from the Chief Building Official and fees shall be as set out in the Building By-Law.
- 12. Prior to the use of and following installation of any outdoor solid fuel combustion appliance each appliance shall be inspected and approved by the Chief Building Official.
- 13. This by-law shall come into force and effect on the day of passing.
