- Traffic complaints are up in Mississippi Mills mostly regarding the OVRT
- More OPP operated ATV's will be on the trail once personal have completed rider training course
- Speeding is not an issue as far as the data that has been collected on the Speed Spy
- Charges are down due to the legalization of Cannabis there has not been a significant increase in arrests with regards to Opioids
- Narcan has been installed in firefighter kits on a suspected overdose there is no liability for the person administering the Narcan if it turns out not to be an OD there are no medical effects if given to someone who has not OD'd.

Mandate of the Committee

Mission Statement

The Mississippi Mills Community Policing Advisory Committee (CPAC) is to provide a mechanism for independent community guidance, governance and accountability for policing at the local level.

General

The responsibilities of the Mississippi Mills Community Policing Advisory Committee (CPAC) include, but shall not be limited to the following:

- a. To provide input to the Detachment Commander regarding priorities and objectives for police services in the community.
- b. To receive regular reports from the Detachment Commander concerning community policing issues, initiatives and statistics as requested by the Committee.
- c. To ensure meetings are open to the public. When public is excluded such exclusion shall only be done in accordance with Section 35 of the *Police Services Act*.
- d. To receive and address issues brought to the Board's attention by the citizens of Mississippi Mills.
- e. To attend community events and meetings, when reasonably practical and when invited.

Committee Membership

Appointment of Committee

- a. The Committee shall consist of five (5) members. There shall be three (3) members appointed from the community and two (2) members of Council.
- b. All new appointees to the CPAC will receive training with respect to their roles and responsibilities.
- c. The CPAC shall elect a Chair and Vice-Chair and appoint a Secretary-Treasurer.
- d. All members of the CPAC shall sign a Code of Conduct for Committee / Board members.
- e. The CPAC shall meet at least four (4) times a year and a majority of the members shall constitute a quorum.

Message from the Detachment Commander

I am pleased to present the Lanark Detachment 2018 Action Plan Progress Report in conjunction with our 2017 – 2019 Action Plan. As we look back over the past year and even over the past three years, we recognize the many policing successes we have had:

- Improved community safety and well-being through development of effective working relationships with community partners.
- Demonstrated success identifying members of the community at an elevated level of risk and engaging appropriate community partners before the person is in crisis.
- The development and completion of the Community Plan for Safety and Well-Being and delivering it to our community partners.
- Build on the success of the Lanark County LEAD Nurse who began working at the Lanark County Detachment in August with the goal of adding a second fulltime LEAD Nurse in 2019.
- Reduced instances of property crime and false alarms through engagement with Police Services Boards and Community Policing Advisory Committees to promote education and awareness.

We continue to focus on the reduction of harm and victimization, specifically violent crime, property crime, illicit drugs and cyber crime. Once again, provincial targeted outcomes have been identified and we will work together to achieve these provincial targets into 2019.

Lanark Detachment remains committed to a traffic safety approach that will change driver behaviours responsible for injuries and deaths on roadways, waterways and trails. We are also committed to further reducing the number of false alarms which continue to misdirect law enforcement resources in OPP communities.

As we look forward, we will continue to ensure our communities have the service delivery they require. The focus of the next three years for our detachment will be:

- Support and be a champion of the Lanark County Situation Table to identify community members who are at an acutely elevated level of risk, and engage community partners prior to crisis.
- Build on the current Lanark County LEAD mental health nurse embedded within Detachment. Continue to expand partnerships with police and health care providers. Continue to explore new opportunities to reduce the criminalization of persons in mental health crises.
- Reduce violence against women and victimization of vulnerable and marginalized populations including the young and the elderly through programs such as: Interval House and Child Youth Advocacy Centre.
- Keep fatal and personal injury collisions at or below current levels through proactive traffic enforcement including R.I.D.E., Provincial and local traffic campaigns. Partnering with MTO in order to identify environmental and physical challenges on our Provincial highways.

The dedication of our members, together with the support of our municipalities, will ensure our continued success in keeping our communities safe.

Our Detachment

The eight Municipalities policed by the Lanark County Detachment are the Towns of Mississippi Mills, Perth and Carleton Place, and the Townships of Beckwith, Montague, Drummond/North Elmsley, Tay Valley and Lanark Highlands.

The Police Services Boards and Community Policing Advisory Committee of the municipalities we serve are active and engaged to ensure the best service delivery possible by the Lanark County Detachment.

We work in close partnership with many community organizations including the Smiths Falls Police Service.

Highway 7 is a major Provincial Highway that bisects the Lanark County Detachment patrol area with a significant amount of vehicular traffic flowing between Ottawa and the Greater Toronto Area (GTA).

Many inland lakes and a portion of the Rideau waterway are within the patrol boundaries and, as a result, there is a significant increase in population during the summer months created by seasonal properties.

The most recent census shows the population of Lanark County at approximately 57,000 people, excluding Smiths Falls.

The majority of residents identify English as their first language.

There is no significant commercial growth in any of the municipalities.

The main areas experiencing residential growth are Carleton Place, Mississippi Mills and Beckwith.

Violent Crime – Assault and Domestic Violence

- There were 181 incidents of assault in 2018, and of that, roughly half were domestic-related.
- Domestic Violence continues to impact many facets of society within Lanark County. Reducing the number of incidents of Domestic Violence has been identified by several Police Services Boards/Community Policing Advisory Committees as being of significant importance to their communities.
- There was a decrease in incidents of assault from 2016 to 2017; however, in 2018, there was an increase.

Property Crime – Thefts From Motor Vehicles

Priority Description:

- Work with community partnerships to enhance community education and awareness supplemented by analyticdriven enforcement to reduce the incidents of thefts from motor vehicles.
- This is easily one of the most preventable property crimes as most thefts are from unlocked vehicles.
- There were 384 incidents of theft under \$5,000, a 9% decrease from 2017, with the overwhelming majority of those incidents being thefts from motor vehicles

Property Crime – Break and Enters

- Work with community partners to enhance education and awareness supplemented by analytic-driven enforcement to reduce the incidents of break and enter.
- There was a very modest increase in break and enters, with 101 incidents reported in 2018 compared to 135 in 2017. This represents a 16% decrease. The trend for the past three years is fairly stable at approximately 123 incidents per year.

The motorcycle driver has been identified as Robert PRATT, age 69 of Ottawa, Ontario. He was transported to hospital in critical condition where he was pronounced deceased. Subject: Ongoing problem of drinking and littering, hooliganism and theft on Clayton Rd

Dear Councillors,

I am writing as a resident of Ramsay Ward to raise the ongoing issue of drinking in a vehicle, discarding the beer bottles and cans, hooliganism, damage to, and theft of private property on Clayton road.

Myself and other residents of Clayton Rd and Concession 3b are very familiar with the uncitizenly behaviour of drivers drinking and throwing there empty beer bottles and cans, as well as other garbage onto the verges of Clayton Rd. We listen to the revving engines of trucks and 4wheelers at night and regularly collect the discarded cans and bottles. This unsociable and in fact, criminal behaviour is bad enough. However, on Friday night (26th July) we suffered vandalism of all of the mailboxes in the area close to Concession 3b - around 8 in total. Our mailbox, handmade by my father-in-law, was removed and stolen. Other boxes were destroyed and the posts snapped off. This is not the first time this has happened. I have been informed by neighbours on 3b that they have had to move their mailbox previously due to vandalism, and that there was talk of a community mailbox to prevent this happening but nothing ever came of this.

I reported the incident of the 26th to the OPP in Carleton Place, but was told that while they would make a report of the incident, they would not send an officer out as they do not have sufficient resources. I informed them about the vandalism, theft and apparent drink driving, but it seems this is not a priority given their limited resources.


What can be done about this issue and how can it be addressed by council? Can we request a community mailbox? That would prevent at least the recurring vandalism, if not the drinking and littering.




I told her I would pass it along to be discussed at the PSB meeting for the police to monitor the area.


